1. CAN KEEP COMMO GEAR AT NEW SITE OR PASS TO [] CUTOUT. TRANSPORTATION FROM OLD SCRANTON AREA NO PROBLEM.
2. HAVE MADE COMPLETE RECON NEW AREA. BOTH GOOD AND BAD FACILITIES FOR TRAINING. SECURITY EXCELLENT. BOUGHT ENOUGH FOOD FOR TWO WEEKS. MORALE A LITTLE LOW. GAVE TWO HOUR POLITICAL LECTURE. EVACUATED TWO MEN, ONE SERIOUS INTERNAL INJURIES DURING MOVE FROM SARANAC, OTHER IS MALARIA CASE. AWAITING ADVICE FROM LINC ON DISPOSITION OF MEN.
