THE TRIAL OF
FORMER ESPECIALISTA JESUS NOEL ((~~DE~~ BETETA)) ACCUSED OF THE
MURDER, HAS PROGRESSED SINCE THE TRANSMISSION OF REF TO THE
POINT WHERE A VERDICT ON BETETA'S GUILT OR INNOCENCE IS
EXPECTED WITHIN THE NEXT TWO WEEKS. WE WILL ADVISE THE
OUTCOME.

ON 8 FEBRUARY, MET DISCUSS RECENT
EVENTS CONNECTED TO THE TRIAL INCLUDING THREATENING LETTERS
RECEIVED BY TWO WITNESSES TO THE MURDER FROM ONE "OMAR
JACKSON." HELEN MACK ASSISTED THE WITNESSES IN OBTAINING
TEMPORARY SANCTUARY FROM THE CANADIAN GOVERNMENT

RECENT LOCAL PRESS REPORTS CLAIMED BOTH THE
WITNESSES AND HELEN MACK HAD BEEN RECEIVING DEATH THREATS, BUT
MACK LATER DENIED THAT SHE, HERSELF, HAD BEEN THREATENED.

COPIES OF ORDERS
WHICH INSTRUCTED THE SECURITY SERVICES
TO EXTEND FULL PROTECTION TO HELEN MACK AND ALL
WITNESSES. (PRESIDENT SERRANO HAD INSTRUCTED TO
ISSUE THE ORDERS.)

TWO WITNESSES RECEIVED THREATENING LETTERS AND SAID [REDACTED] HAVE ALREADY DETERMINED THAT "OMAR JACKSON" IS A FAKE NAME. [REDACTED] DETERMINED THE CREDIBILITY OF THE WITNESSES AGAINST BETETA, SAYING THEY HAD "IDENTIFIED" AN UNIDENTIFIED INDIVIDUAL HANGING AROUND THE MURDER SCENE (BEFORE THE MURDER), WHO WAS WEARING A MOTORCYCLE HELMET AS BEING BETETA. HE SAID BETETA IS INNOCENT AND HE SPECULATED THE CIRCUS OF PRESS PLAY SURROUNDING THREATS AGAINST THE WITNESSES ONLY SERVED TO ENHANCE THE WITNESSES' CREDIBILITY.

[REDACTED] AN INTERNAL ARMY INVESTIGATION BOARD LOOKING INTO THE MYRNA MACK CHANG MURDER BECAUSE OF THE ACCUSATIONS MADE BY HELEN MACK. HE IDENTIFIED ONE OTTO ((BARRIOS)) ALONGO AS THE PROBABLE SOURCE FOR HELEN MACK'S BELIEF THAT [REDACTED] PLANNED AND CARRIED OUT THE MURDER. HE SAID BARRIOS, PRESENTLY AN EMPLOYEE IN THE MINISTRY OF GOVERNMENT, IS ONE OF HELEN MACK'S PRINCIPAL GOVERNMENT CONTACTS AND HAS AN AXE TO GRIND AGAINST THE SECURITY SERVICES. [REDACTED] SAID BARRIOS IS AN EX-MILITARY OFFICER WHO THE SECURITY SERVICES IDENTIFIED AS INVOLVED IN NARCOTICS TRAFFICKING AND COMMERCE IN STOLEN CARS FROM THE UNITED STATES. [REDACTED] SUPPORTS [REDACTED] IDENTIFICATION OF BARRIOS AS A MILITARY OFFICER INVOLVED WITH NARCOTICS TRAFFICKERS AND IN A CAR THEFT RING.) BARRIOS WAS DISMISSED FROM THE ARMY AS A RESULT OF THE INVESTIGATION BY SECURITY SERVICES. [REDACTED]
