1. On 17 March the United States Intelligence Board (USIB) in considering reference a was advised of the need to revise the Board's current satellite SIGINT requirements (reference b).

2. The Committee on Overhead Reconnaissance (COMOR) submits in the attachment for the approval of the Board the revision of current satellite SIGINT requirements. In the preparation of this paper the NRO participated fully and advised that the technical requirements outlined are within the current state-of-the-art and that the statement does provide guidance in a form which is adequate for its operational planning.

3. The significant changes made to reference b are as follows: Clarification of stated objectives, refinements of and additions to parameters: measurement accuracies, restatement of periodicity of coverage, and the inclusion of a new COMINT requirement. The results of this updating are expected to provide higher quality data and to facilitate more

Current Satellite SIGINT Requirements

Introduction

1. This paper presents the United States Intelligence Board's current satellite SIGINT collection requirements. As the NRO develops capabilities and as it manages the operations of those capabilities to meet these requirements, additional collection guidance from the COMOR will be necessary and will be provided as a regular matter.

2. In determining the requirements for satellite SIGINT collection, no reference has been made to a particular system or systems to which the requirements may be assigned. Experience has shown that a system designed to meet one category of requirements can contribute to the satisfaction of other categories.

As the NRO develops capabilities and as it manages the operations of those capabilities to meet these requirements, additional collection guidance from the COMOR will be necessary and will be provided as a regular matter.

2. In determining the requirements for satellite SIGINT collection, no reference has been made to a particular system or systems to which the requirements may be assigned. Experience has shown that a system designed to meet one category of requirements can contribute to the satisfaction of other categories.
