Incident - 25 January 1993  
Administrative Report

- 7:57 [redacted] C, [redacted] arrived on duty and was informed of shooting incident at the Route 123 entrance by [redacted], R.N. The emergency team had responded immediately and left at 7:55 A.M.
- 8:05 C, [redacted] spoke with the security duty office offering additional medical assistance including three physicians and additional nurses. Security Duty officer (SPO) reported that there was adequate medical support which included the OMS Team as well as the Fairfax Fire & Rescue Squad.
- 8:10 Gary Foster, Director, Public and Agency Information called for information on incident. Chief, [redacted] Branch responded there was believed to be six victims, two dead.
- 8:16 Security Duty Office reported list of known victims:  
Nick Starr - critical with chest and arm wounds  
Steve Williams - flesh wounds  
Judy Becker Darling - in shock (had been in car with husband when he was shot, condition unknown)  
? names other victims  
? Names dead
- 8:30 Two witnesses arrived in the dispensary. Dr. [redacted] was contacted by the [redacted] Branch and immediately established a [redacted] Division support team.
- 10:15 The media reported three of the victims were dead. [redacted] R.N. established contact with Fairfax Hospital E.R. During the rest of the day we were given an hourly update on how Mr. Starr's surgery was progressing.
- 11:30 [redacted] R.N. & Dr. [redacted] went to Mrs. [redacted]'s place of employment to be of emotional support. Mrs. [redacted] had previously been a member of the [redacted] Branch. (See attached)
- 12:20 OMS Team arrived at Mrs [redacted] Office.
- 5:00 Follow-up contact has been made with Fairfax Fire & Rescue Squad. February 19th

0750 [redacted] R.N., received call on [redacted] from security that a shooting incident had occurred at the Route 123 gate with 5 injured [redacted] requested transportation to be meet team at front entrance

Emergency team responded immediately. Team included:

[redacted] R.N., [redacted] R.N., [redacted] M.D., [redacted] P.A., [redacted] MSO

Transported by mini-bus to 123 gate by motor pool driver [redacted] to VCC

Fairfax Fire & Rescue on scene upon arrival

Approached security for report of situation

Informed of two dead on Route 123  
One badly wounded (Nicholas Starr) in ambulance at entrance gate  
One wounded [redacted] in car in parking area  
One in shock (Judith Becker Darling) in VCC

[redacted] R.N., [redacted] PA & [redacted] MSO went to parking area

[redacted] - no obvious wound, lung sounds clear; bullet appeared to have grazed skin surface.

[redacted] & [redacted] stayed with patient until ambulance arrived.

[redacted] R.N. went with security to VCC to assist Judith Becker Darling

[redacted] R.N. & [redacted] M.D. went in ambulance with Nicholas Starr to assist medics. [redacted]

patient placed in helicopter and transported to Fairfax Hospital Trauma Center .

Report from hospital indicated it was twenty two minutes from arrival of medics on scene to patients arrival at trauma center.

[redacted] R.N. & [redacted] M.D.were transported by medics back to VCC

[redacted] R.N. & [redacted] M.D. reported in at VCC with [redacted] R.N. assisted with Judith Becker Darling until she was taken by Fairfax County Rescue to hospital.

[redacted] M.D. called in to dispensary to give report

Before leaving VCC contact was made with  (witness). Assistance offered - told to ~~call or come to~~ see us in OMS if we could help her.

Follow-up contact has been made with Fairfax Fire and Rescue to have a post-incident meeting.
