1. "Contreras" is chief of the Laboratorio Quimico (Chemical Laboratory - LQ) in the MI Section (Department of Technical Operational Support) of the Direccion General de Inteligencia (General Directorate of Intelligence - DGI). His superior is Guillermo ARASTAGUIA.

2. "Contreras," a Cuban citizen, is married to "Vidalina" (see CSCI-316/00741-65, 16 February 1965). He was born between 1930 and 1935, is five feet seven inches tall, weighs about 150 pounds, and has a medium build. "Contreras" is a mulatto.<sup>1</sup>
