AS YOU MAY OR MAY NOT BE AWARE, I WAS REQUESTED VIA REF A BY D/CPAS (CHIEF, HONDURAS WORKING GROUP) TO PROVIDE COMMENTS ON A VARIETY OF ISSUES SPANNING SEVERAL YEARS IN THE 1980'S DEALING WITH AGENCY OPERATIONS, HUMAN RIGHTS ISSUES [REDACTED] IN HONDURAS. FOR THE MOST PART, I AM NOT QUALIFIED TO ANSWER [REDACTED] HOWEVER, THERE ARE PERTINENT QUESTIONS IN REF A QUESTIONNAIRE DEALING WITH [REDACTED] THIS WAS NEARLY 10 YEARS AGO, AND I CANNOT DO JUSTICE TO THESE QUESTIONS, OR MAKE AN ACCURATE AND COMPLETE CONTRIBUTION TO THIS INQUIRY WITHOUT HAVING AN OPPORTUNITY TO REVIEW THE RELEVANT DOCUMENTARY RECORDS, TO INCLUDE [REDACTED] INTEL REPORTING AND CABLE CORRESPONDENCE WITH HQS DURING THE PERIOD IN QUESTION. I THEREFORE REQUEST YOUR CONCURRENCE WITH MY VISIT TO HQS FOR CONSULTATIONS WITH LA DIVISION 6-9 FEBRUARY 96. I ALSO ASK THAT THE DIVISION HELP ME MAKE EFFICIENT USE OF MY TIME THERE BY ASSEMBLING THE RELEVANT DOCUMENTS PRIOR TO MY ARRIVAL. IF YOU APPROVE, I WILL DEPART [REDACTED] ON MONDAY 5 FEBRUARY, AND REPORT TO LA DIVISION AT HQS OOB 6 FEBRUARY.

I JUST RECEIVED REF A FROM D/CPAS TODAY, 1 FEBRUARY. IT WAS SENT [REDACTED] 30 JANUARY, [REDACTED] THE QUESTIONNAIRE REQUESTS MY RESPONSE BY COB 6 FEBRUARY. GIVEN THE FACT THAT I MUST REVIEW DOCUMENTS AT HQS IN ORDER TO RESPOND, AND FEEL THAT I SHOULD NOT PULL MYSELF AWAY FROM DUTIES [REDACTED] UNTIL THE 5TH, THE 6 FEB REPORTING DATE DOES NOT APPEAR POSSIBLE TO MEET. IN REF B, SENT TO D/CPAS ONLY, I ADVISED OF MY INTENT TO RETURN TO HQS TO REVIEW RELEVANT DOCUMENTS PRIOR TO SUBMITTING MY FORMAL RESPONSE, AND I REQUESTED AN EXTENSION OF MY RESPONSE DATE DEADLINE UNTIL COB 8 FEBRUARY. I SHALL APPRECIATIVE ANYTHING YOU CAN DO TO PERSUADE D/CPAS TO GRANT THIS EXTENSION REQUEST.

[REDACTED] YOU CAN THEREFORE EXPECT TO SEE SOON AN INFO COPY OF AN ABBREVIATED PARALLEL MESSAGE [REDACTED] IN THAT MESSAGE I WILL REQUEST [REDACTED] APPROVAL FOR MY ABSENCE FROM [REDACTED] AND THEIR APPROVAL OF THE TRAVEL AND HQS CONSULTATIONS. FUNDING SHOULD NOT BECOME AN ISSUE, SINCE I EXPECT [REDACTED] CONCURRENCE, BUT IF [REDACTED] BALKS FOR SOME REASON, I AM PREPARED TO PAY FOR THIS TRAVEL HOME OUT OF PERSONAL FUNDS, AND TO TAKE THIS TIME AS A.L., IF THAT IS WHAT IT TAKES. I WANT TO GET THIS RESPONSE RIGHT -- FROM THE START.

I WOULD HAVE PREFERRED A MORE CHEERFUL THEME FOR MY CORRESPONDENCE WITH YOU. I APPRECIATE YOUR ATTENTION TO THIS MATTER, AND LOOK FORWARD TO SEEING YOU AT HQS NEXT WEEK.


