SUBJECT : SCHEERCASE

Re: Jessica Mitford TREUHAF

1. Reference is made to our memorandum, CSCI-316/01136-67 dated 10 March 1967, entitled SCHEERCASE in which we advised that we were conducting further research concerning several known contacts and associates of Robert SCHEER, who is Managing Editor of Ramparts magazine. Jessica Mitford TREUHAF has been listed on the masthead of Ramparts as Associate Editor during the period March 1966 to October 1966, and under the name Jessica MITFORD as Oakland Contributing Editor of Ramparts during the period November 1966 to the present time.

2. Jessica Mitford TREUHAF was born 11 September 1917, Batsford, Gloucestershire, England, daughter of Lord and Lady RENSDALE (OR REDESDALE). She studied in Paris, France, at the Sorbonne. Her sister, Dianna MITFORD, married the British Fascist Sir Oswald MOSELY. Another sister, Unity MITFORD, was known as the "girl friend" of the German Nazi leader Adolph HITLER. In 1939 she came to the United States and was naturalized on 3 January 1944. From 1942 to 1944 she was employed by the British Purchasing Commission in Washington and in San Francisco, California. On 21 June 1943 she married Robert Edward TREUHAF, a graduate of Harvard Law School (1937). Both were active in the Communist Party in San Francisco until 1958 when they reportedly resigned.






