Re: FOIA Request – Policy on Counsel’s Access

Dear Mr. Koch:

This is a request on behalf of The James Madison Project under the Freedom of Information Act, 5 U.S.C. § 552, et seq., for copies of all internal Central Intelligence Agency (“CIA”) documents constituting guidelines, regulations or policy memoranda pertaining to coordination with outside counsel representing CIA employees, including, but not limited to, the ability of outside counsel to meet with clients at CIA Headquarters without an official escort other than the client and the granting of security clearances to outside counsel for information relevant to the client’s interests. Additionally, please provide copies of all internal CIA documents pertaining to the enclosed letters which I submitted to the CIA, under the aegis of my former law firm and dated September 2004 and December 2004, seeking a clarification of this policy from Jo Bennett, then-Acting Chief for Litigation for the CIA, and John Rizzo, then-Acting General Counsel for the CIA. To date, I have not received any answers in response to those letters.

If you deny all or part of this request, please cite the specific exemptions you believe justifies your refusal to release the information or permit the review and notify us of your appeal procedures available under the law. In excising material, please “black out” rather than “white out” or “cut out”.

Understanding the guidelines or memoranda that form the basis of this policy will clearly contribute to the public's understanding of government operations or activities.

Please respond to this request within 20 working days as provided for by law. Failure to timely comply may result in the filing of a civil action against your agency in the United States District Court for the District of Columbia. Your cooperation in this matter would be appreciated. If you wish to discuss this request, please do not hesitate to contact me at either (202) 498-0011 or my law office at (202) 454-2809.


