Dear Mr. Eldredge:

In accordance with Executive Order 9621 terminating the Office of Strategic Services and creating the Strategic Services Unit of the War Department, it is necessary to continue the partial liquidation of Strategic Services Unit. This liquidation is to be made in accordance with the regulations and procedures of the Civil Service Commission.

It has been determined that you are one of the employees to be separated and your services with this office will be terminated at the close of business on 13 January 1947. You may be continued in a pay status throughout this period if the work load in your office will permit or if you have sufficient annual leave.

You are entitled to examine the regulations pertaining to this reduction if you so desire. These regulations are available for inspection in Room 112, North Building. If you believe that there has been a violation of your rights under these regulations, you may appeal in writing to the Civil Service Commission, Washington 25, D. C., within 10 days from the date you receive this notice. If you file an appeal, you should indicate the date of your separation, the date of this notice, and the reasons for your appeal.

If you have reemployment rights, you should apply to the agency concerned for reinstatement not later than 40 days after the effective date of your separation from the rolls of this office. Further information may be procured from the Employment Section, Personnel Division, Room 111, North Building.

The service which you have rendered is appreciated as it has been a real contribution to the war effort. We trust the experience you have gained will prove profitable to you. It is our sincere hope that you will be successful in finding another suitable position in the near future.
