1. THE NORTH VIETNAMESE AT THE GENERAL DELEGATION OF THE DEMOCRATIC REPUBLIC OF VIETNAM (DRV) IN PARIS STATED THAT PLANS FOR THE WAR CRIMES TRIAL IN PARIS ARE FAR FROM COMPLETE. SUCH PUBLICITY SO FAR IN ADVANCE OF THE EVENT MAY FRIGHTEN THE FRENCH GOVERNMENT INTO WITHDRAWING ITS TACIT SUPPORT. THE TOP NEGOTIATOR FOR THE TRIAL PREPARATIONS IS HOANG QUOC VIET, CHIEF PROCURATOR OF THE PEOPLE'S SUPREME PROCURATE, WHO HAD VISITED PARIS SEVERAL TIMES THIS YEAR.
