WITH THE EXCEPTION OF STOKELY CARMICHAEL (LEADER OF THE US STUDENT NON-VIOLENT COORDINATING COMMITTEE) AND FORMER MEXICAN PRESIDENT LAZARO GARDENAS, THE ENTIRE TRIBUNAL MEMBERS ARE EXPECTED TO BE PRESENT AT THE LONDON MEETING.

VEHEMENTLY MAINTAINED THAT THE WAR CRIMES TRIAL WILL BE HELD IN PAIS IN MARCH 1967 AS PLANNED. HOWEVER IF THERE IS ANY DIFFICULTY, WHICH THE ORGANIZERS DO NOT EXPECT, THE TRIBUNAL COULD BE HELD IN STOCKHOLM. ACCORDING TO [] THE SWEDISH GOVERNMENT HAS SHOWN CONSIDERABLE SYMPATHY AND WOULD NOT PREVENT HOLDING THE EVENT IN STOCKHOLM.
