

PREPARATORY MEETING OF THE INTERNATIONAL WAR CRIMES TRIBUNAL. HOWEVER, THERE HAVE BEEN NUMEROUS REFERENCES, INCLUDING ONE BY RUSSELL, TO A JANE CH'ENG WHO HAS BEEN A RESEARCH COLLABORATOR OF CADART FOR SOME YEARS AND WHO WAS ASSISTING HIM BERTRAND RUSSELL PEACE FOUNDATION IN THE WORK OF THE PARIS OFFICE OF THE (BRPF.) SHE IS CONSIDERED BY SOME TO BE CADART'S MISTRESS. CH'ENG, WHO WAS FORMERLY MARRIED TO AN ENGLISHMAN NAMED (FNU) HOOD, IS NOW ABOUT 35 YEARS OLD AND WAS BORN IN CANTON OF CHINESE PARENTS. THE ADDRESS AND TELEPHONE NUMBER OF CH'ENG IS IDENTICAL WITH THAT USED BY LILY PENG.)

2. THE FOLLOWING HAVE PERIPHERAL RESPONSIBILITIES IN THE TRIBUNAL:

- A. CLAUDE LANZMAN IS TRIBUNAL MEMBER JEAN-PAUL SARTRE'S LIAISON OFFICIAL WITH THE TRIBUNAL.
- B. CATHERINE RUSSELL IS INVOLVED WITH DOCUMENTATION AND RESEARCH.
- C. FERANDA SANTANA HAS BEEN HELPING IN THE TRIBUNAL'S LONDON OFFICE AND IS TO RETURN TO MEXICO, BUT IS EXPECTED BACK IN LONDON.
