BECAUSE OF TRIBUNAL MEMBER JEAN-PAUL SARTRE'S CURRENT TRIP TO ISRAEL. [Redacted] COMMENT: [Redacted] REPORTED IN MID-MARCH THAT MICHEL CONTAT, A SWISS FROM LAUSANNE WHO HAS BEEN COMPILING A BIBLIOGRAPHY ON SARTRE AND WHO IS APPARENTLY CLOSE TO SARTRE, SAID THAT SARTRE HAS MIXED FEELINGS ABOUT THE TRIBUNAL AND SOME OF THE PEOPLE ASSOCIATED WITH IT. CONTAT ADDED HOWEVER THAT SARTRE FELT STRONGLY THAT WORLD PUBLIC OPINION SHOULD BE MOBILIZED AGAINST THE VIETNAM WAR.) AMERICAN NEGRO AUTHOR JAMES BALDWIN WILL ALSO BE PARTICIPATING IN THE TRIBUNAL AND WILL BE COMING FROM TURKEY, WHERE HE IS STAYING, TO PARIS AT THE END OF APRIL. SINCE THERE ARE MANY PROBLEMS INVOLVING THE SCHEDULING OF PARTICIPANTS DURING THE SUMMER OF 1967, THE TRIBUNAL MIGHT NOT END UNTIL SEPTEMBER.
