(SNCC) DELEGATES [Redacted] FEEL THAT THIS IS A
 STRUGGLE BETWEEN THE TROTSKYITES (ENGLISH SPEAKERS)

 WERE MOST UNHAPPY OVER THE SITUATION.

3. IN GENERAL THE FRENCH GROUP STAYS TOGETHER

5. [] STATED THAT THERE WAS A "FRENCH-LED COUP" DESIGNED TO TRANSFER THE TRIBUNAL HEADQUARTERS TO PARIS AND TO EVENTUALLY DROP SCHOENMAN AS SECRETARY GENERAL. [] STATED THAT VLADIMIR ~~DEDIJER~~ DEDIJER STRONGLY DISLIKES SCHOENMAN AND VOTED WITH THE FRENCH TO MOVE THE HEADQUARTERS TO PARIS DESPITE THE FACT THAT THE FRENCH GOVERNMENT WILL NOT GRANT HIM A VISA TO VISIT PARIS.

6. IN THE FACE OF THE OPPOSITION FROM THE FRENCH THE RUMORED SPLIT BETWEEN STETLER AND SCHOENMAN HAD VANISHED AND THERE ARE NO SIGNS OF ANY CONFLICT. STETLER HAS MADE COMPLIMENTARY REMARKS ABOUT SCHOENMAN'S DRIVE AND COMMITMENT.
