RUSSELL STETLER, JR., MEMBER OF THE SECRETARIAT OF THE INTERNATIONAL WAR CRIMES TRIBUNAL, SENT A CABLE IN SPANISH ON 27 APRIL 1967 TO HABANA WHICH URGED THE AFRO-ASIAN-LATIN AMERICAN PEOPLE'S SOLIDARITY ORGANIZATION (AALAPSO) TO SEND A DELEGATION TO STOCKHOLM TO PRESENT ITS "TESTIMONY" TO THE TRIBUNAL.
