

2. Austryn Wainhouse, an American who has been living in the south of France, arrived at the International War Crimes Tribunal in Stockholm, together with Carl Oglesby. Wainhouse claims to have been following the work of the Tribunal and to have been active in France on behalf of the North Vietnamese. He is a friend of Professor Gabriel Kolko (who has appeared before the Tribunal) and his wife. Wainhouse stated he has a contract with Grove Press of New York to write a book on North Vietnam, but he has not been able to get a visa to go there. [redacted] commented that he thinks Wainhouse's father was at one time an employee of the State Department. He also thinks Wainhouse is a friend of Richard Weaver, editor of Grove Press.)

3. David Thorsten has joined the staff of the Tribunal. An American in his 20's from Wisconsin, Thorsten is a member of the Trotskyite Young Socialist Alliance. Thorsten, who speaks French and some Norwegian, has been in Europe for six months and worked as a volunteer for the Bertrand Russell Foundation documentation center in Paris. He is now on a small salary. He observed that the London Tribunal staff does not send much money to the office in Paris. Thorsten plans to return to the US in August.

He also plans to make a film on the Tribunal. Duffit claims to be in touch with the American film producer, ~~Lionel~~^{U.S.} Rogosin in ~~London~~^{ENG.}, who gave him a small advance on the film.
