1. The Swedish contingent in the offices of the International War Crimes Tribunal during the 2 - 10 May 1967 Tribunal Session in Stockholm was composed of four separate groups:

- a. Young Philosophers - left wing discussion group
- b. revisionist wing of the Swedish Communist Party
- c. Social Democratic Youth
- d. pro-Chinese Swedish Communists - who describe themselves as "Marxist-Leninists".

2. Tribunal Secretary General Ralph Schoenman's liaison with the Swedish Tribunal Committee has been through Joachim Israel and Erik Eriksson. Eriksson is a member of the Young Philosophers and, during the Tribunal Session, Schoenman seemed closer to the Young Philosophers than to any of the other groups which were among the Swedish contingent to the Tribunal.

1. [Redacted] Comment: According to [Redacted] 11 May 1967, Israel was the Swedish organizer of the Stockholm Tribunal Session, and had reportedly mortgaged his home to pay the Tribunal deficit.
