

1. THE THIRD SESSION OF THE INTERNATIONAL COMMISSION OF ENQUIRY INTO US CRIMES IN INDOCHINA, A COMMISSION OF THE STOCKHOLM CONFERENCE ON VIETNAM, IS SCHEDULED TO TAKE PLACE IN EARLY AUTUMN 1972 AND WILL BE HELD IN EITHER LONDON, ENGLAND, OR COPENHAGEN, DENMARK. THE MAIN TOPICS TO BE DISCUSSED ARE:

STRESS WILL BE PLACED ON ECOLOGY. ONE STATEMENT ON ECOCID WILL BE ISSUED AND MORE WILL BE PREPARED DURING THE SESSION.

2. MAURITZ SUNDQUIST, A KEY MEMBER OF THE STAFF OF THE STOCKHOLM CONFERENCE ON VIETNAM, WOULD LIKE TO HAVE EITHER ALEXSANDR BERKOV

(FORMER SOVIET "ADVISOR" TO THE STOCKHOLM CONFERENCE) OR DR. GRIGORIY

LOKSHIN (SECRETARY FOR THE SOVIET COMMITTEE IN SUPPORT OF VIETNAM) TO

GO TO STOCKHOLM TO ASSIST HANS GORAN FRANCK. SHE INDICATED THAT FRANCK,

WHO IS CHAIRMAN OF THE INTERNATIONAL COMMISSION OF ENQUIRY, WOULD NEED HELP IN HIS WORK OF THE WAR CRIMES COMMISSION BECAUSE HERETOFORE HE HAD BEEN DEPENDENT

ON THE CHAIRMAN OF THE STOCKHOLM CONFERENCE, BERIL SVAHNSTROM,

WHO DIED ON 16 JULY 1972. OF 18 JULY 1972 REPORTED THAT

BERKOV AND LOKSHIN HAD BEEN ADMITTED TO ATTEND A SPECIAL MEETING OF THE EXECUTIVE

BUREAU OF THE STOCKHOLM CONFERENCE OCCASIONED BY THE DEATH OF SVAHNSTROM. IT

WAS SCHEDULED TO BE HELD IN PARIS ON 19 JULY 1972. SUNDQUIST HAD HOPED THE TWO

SOVIETS COULD RETURN FROM PARIS BY WAY OF STOCKHOLM. THAT REPORT, HOWEVER,

INDICATED THAT ACTUALLY NEITHER WOULD GO TO PARIS.) SUNDQUIST IS CONCERNED THAT

THE WORK OF THE COMMISSION SHOULD CONTINUE WITHOUT INTERRUPTION. FRANCK AND OTHER

MEMBERS OF THE COMMISSION ARE SCHEDULED TO DEPART ON 28 JULY 1972 FOR VIETNAM

FOR AN ON-THE-SPOT INVESTIGATION.

AT THE EXECUTIVE COMMITTEE MEETING OF THE STOCKHOLM CONFERENCE ON VIETNAM HELD IN STOCKHOLM, SWEDEN, 1 - 2 JULY 1972, FRANCK REPORTED THAT THE SECOND SESSION OF THE WAR CRIMES COMMISSION WHICH TOOK PLACE IN OSLO, NORWAY, IN JUNE 1971, HAD RESULTED IN THE PRODUCTION OF TEN FILMS, NUMEROUS PAMPHLETS AND BOOKS IN SEVERAL LANGUAGES, ALL OF WHICH WERE WIDELY DISTRIBUTED.

4. IN JUNE 1972 A SWEDISH TV TEAM HEADED BY ERIK ERIKSSON TRAVELLED TO NORTH VIETNAM. A FILM WAS PRODUCED ENTITLED "DAMAGE TO DIKES" WHICH HAS BEEN TRANSMITTED ON TV NETWORKS OF SEVERAL COUNTRIES. ANOTHER SWEDISH TEAM HEADED BY STAFFAN WILDEBRAND WILL GO TO LAOS IN THE NEAR FUTURE, AND ATTEMPTS ARE BEING MADE TO CONVINCE AN AMERICAN PROFESSOR TO ACCOMPANY THE TEAM. COMMENT: THE PROFESSOR WAS NOT FURTHER IDENTIFIED.)
