AT APPROXIMATELY 1400, 1 APRIL 80. HE SAID HE HAD A STRONG PSYCHIC MESSAGE THAT SENATOR TED KENNEDY WOULD BE ASSASSINATED WHILE LEAVING MASS ON SUNDAY, 6 APRIL. THE ATTACKER ALLEGEDLY WOULD USE A KNIFE, NOT A GUN. THE CALLER SAID HE WAS PROVIDING THIS INFORMATION IN THE HOPE THAT THIS TRAGEDY WOULD BE AVERTED. HE SAID THAT THERE HAD BEEN ENOUGH GOOD MEN KILLED, NAMING SAN FRANCISCO SUPERVISOR HARVEY MILK AND MAJOR GEORGE MOSCONE. THE CALLER WOULD NOT FURTHER IDENTIFY HIMSELF. HE SAID THAT IF ANYONE WANTED TO CONTACT HIM, HE IS WELL-KNOWN IN THE SAN FRANCISCO GAY COMMUNITY AS "SUNSHINE, THE PSCHIC". HE SOUNDED CONCERNED AND AGITATED, BUT RATIONAL."
