[redacted] Your correspondence seeks clarification of the CIA Office of Inspector General (OIG) determination that there were no illegal activities by the CIA or any of its officers during the course of the reported incident. [redacted]

[redacted] As a result, OIG sent a memorandum to the Director, CIA on 14 March 2006 reporting on a "particularly serious problem" which CIA Office of Congressional Affairs reported to the Congressional Oversight Committees on 22 March 2006.
