Reference is made to FBI reports, captioned as above, dated 3 July and 1 August 1968. Additional reference is made to a memorandum from this Agency to the FBI, dated 19 July 1968, captioned [REDACTED] Information Concerning.

The FBI report dated 3 July 1968 reflects that when co-Subject's applied for passports on 3 April 1961, they listed the following individual be notified in the event of death or accident: Shad Polier, lawyer, 60 East 42nd Street, New York, New York.

Shad Polier may very well be identical with the Subject of FBI reports captioned, "Shad Polier, aka: Isadore Polier, Security Matter-C" (Bureau file 100-410381).
