<p>It is reported that Hasan Dosti has almost succeeded in making peace within the Balli Kombetar after effecting a reconciliation between Ali Klishura and Abas Fyreni.</p> <p>In September 1949, while the then Greek Under-Secretary of Foreign Affairs Panayiotis Pipinelis was in Rome, Dosti was invited by him to take his colleagues of the Committee for Free Albania and establish them and himself in Greece. Dosti told Pipinelis that he would discuss this question with his colleagues.</p> <p>About 15 April 1950 the Counsellor of the Greek Embassy in Rome, having invited Dosti to confer with him, asked him what he and the other members of the Committee for Free Albania thought of doing in the way of recruiting Albanian refugees in Greece. Dosti allegedly replied that this was a matter of interest not only to him and the members of the Committee but to other Albanians and Americans as well.</p> <p>It is reported that Hasan Dosti has recommended the broadening of the Committee for Free Albania to include the BKI and that his recommendation is receiving serious consideration by persons in the Department of State.</p> <p>Hasan Dosti reportedly wishes to see the new Greek Ambassador in Washington in order to discuss with him the question of Albanian-Greek relations. Because of his distrust of Luci Kotta, Dosti is understood to be planning to keep him in the dark regarding his conversations.</p> <p>Khafiz Dava recently visited Greece and Syria. Source states that Dosti believes the purpose of Dava's trip to have been to see how many men he could recruit from among the Albanian refugees in those countries.</p> <p>Source states that Luci Kotta, who was expected to arrive in New York at the beginning of May 1950, does not enjoy the trust of Dosti, who considers that he is playing a double game; although officially representing the "Legalitet" Party of M. Haxhi Zoti, Kotta tells his intimate friends that he represents the Christian Orthodox Albanians and at the same time he is reported to have assured Said Kryeziu that he is with him and his Agrarian Party.</p>
