RI file #100-1-1-1 contains an application sheet of Subject's son Luan DOSTI, who was born 18 April 1927 at Arjire Castro, Albania. His immigration visa was dated 1 October 1948, and as of 8 Feb. 1952 both he and Subject used 18 Riverside Drive, New York City, as their address. Luan DOSTI's education includes: Liceo "Mirana", Albania; Hunter, September 1949 to February 1950; City College, February 1950.

RI file #100-1-1-1 contains information from ... no. 1, 17, dated 12 October 1949 in which it is stated that Subject was born at Arjrokastro, Albania, on 12 October 1927 and was living at 18 Riverside Drive, New York City, c/o "Mehmet Lolo."

RI file #100-1-1-1 is a memorandum from Chief, FBI, dated 26 November 1951, attaching a letter accusing Subject of collaboration with both Germans and Communists. It is stated that the letter was apparently written out of personal rancor by a not unprejudiced observer. It is stated that on the basis of Subject's wartime resistance role with The Balli Kombetar and his present anti-communist activities with the NCFA, it is inconceivable that he should be denied entrance to this country as the result of such an unsubstantiated letter.

RI file #100-1-1-1 is a memorandum dated 1 July 1952, from the Dept. for Police Coordination, SE, requesting that the Alien Affairs Officer take appropriate representation to the Bureau of Immigration and Naturalization to issue Subject, Chairman of the National Committee for a Free Albania (NCFA), a re-entry permit to the United States. It was stated that Subject plans to depart from New York for Germany on 25 July 1952, and would be on business for the NCFA while in Europe.

RI file #100-8-12-27 (DFB-2190) is a government agency report, dated 22 September 1952, concerning Albanian Activities in the United States. A confidential informant, of unknown reliability, stated that in his opinion the NCFA has been derelict in its assumed duties as an anti-communist organization. The informant stated that the committee has actually created a disunity of action among the anti-communist emigre groups and that the committee has, therefore, not been of any real benefit and welfare to the people of Albania. The informant explained that this disunity has come through persistent refusals of Subject, Chairman of NCFA, to include the two largest nationalist groups - Balli Kombetar Organization and Balli Kombetar Independent - in membership of the Committee. He stated that Subject, who claims that he is the leader of the Balli Kombetar in this country, is in reality a leader, and one of the founders of the Albanian Democratic Agrarian Party. He stated that Subject, through his threats of abandoning the committee if these other groups were admitted, has caused considerable ill will and disunity, and has been a discouraging factor in the struggle of other emigre groups against communism. The informant contends that this situation has strengthened communism both inside and outside Albania.

Another confidential informant, of known reliability, stated that the leaders of other peasant parties have wished to have Subject ousted from the International Peasant Union or at least to publicly reveal his poor record as a Fascist collaborator in the past.

RI file #100-7-10-102 is a report from Rome, dated 25 January 1953, attaching a report ZD/241, dated 14 November 1952, in which it is stated that an American observer attached to MCFR, Rome, anxious to effect union of all Albanian anti-communist forces, finally recognized that Subject and the Agrarian Alliance group were blocking widening of MCFR in order to protect positions of privilege.

RI file #100-8-12-66, DFR-2974, is a government agency report, dated 24 March 1953, on Albanian activities in the United States. A confidential informant of unknown reliability explained that the Agrarian Party through its leaders, Vasil Andoni and Subject, is representative of an anti-religious element of the Albanian people. He described AEDCMI and Subject as firm believers in Socialism and as being personally and in their political beliefs anti-democratic.

RI file #100-134-2.5-29 is a memorandum for C/IO/TCMIS from the Acting Chief, SE, dated 29 June 1953 transmitting a list of individuals approved for use by SE for broadcasts to Albania. Subject is included in the list, and it is stated that he had no derogatory information on Subject.

RI file #100-8-12-65, DFR-29731, is a government agency report, dated 15 September 1953, on Albanian activities in the United States. An informant, of known reliability and familiar with Albanian activities in the New York City area, stated that he is of the opinion that the MCFR is, under Subject as Chairman, the center of intrigue and the cause of disintegration of the emigre groups not included as members in the committee. He said that the split which has resulted in the national front abroad because of the committee's activities has had unfortunate repercussions among the people of Albania who had placed their hopes in such a committee for the day of their liberation from communism.

RI file #100-14-11-29 is a memorandum from Chief, SE, dated 1 December 1953, requesting that appropriate representation be made to the Bureau of Immigration and Naturalization, to issue Subject, Chairman of MCFR, a re-entry permit to the United States. Subject was planning to depart from New York for Rome on or before 7 December 1953, and was to be on business for the MCFR while in Europe.

RI file #71-6-4-3892 is a dispatch from Chief of Station, [redacted] dated 29 January 1954, forwarding a report received from [redacted] in regard to Balli Kombetar activity in Istanbul against the MCFR. The report states that quazim PRODANI, representative of the Balli Kombetar in Istanbul, sharply criticized Subject who agreed to be president of a committee in which Nazi-Fascists are members. PRODANI called a meeting of the Ballists in Istanbul on 10 January 1954 and the group present decided to send a letter of protest to the committee and to the American and British representatives announcing that the majority of the Balli Kombetar Agrar do not recognize the new committee and will not be represented on a committee which has accepted betrayers of the Albanian people. These persons will seek to organize as soon as possible a general congress of the Balli Kombetar Agrar at which they will present a decision against Subject and anyone collaborating with him.

RI file 120-7-1051 is a report from Italy, dated 9 March 1949, enclosing a copy of Subject's "White Paper". The report enclosing the document states the following: "There is furnished herewith for whatever use Headquarters may desire to make of it, an Italian translation of DOSTI's so-called "White Paper". A hasty perusal of this historic document can only persuade the reader that DOSTI is his own worst political enemy. His fantastic admission of complete ignorance regarding a most basic aspect of his own Party, that is, its membership (page 35 of enclosure), can only point up the weakness of this vessel which has been chosen to act as our PCFA whip".

RI file 120-1-1060, SGAA-9547 is a dispatch from [ ] dated 10 April 1954, enclosing an interrogation report on Mehmet KUCI, covering the period between 25 May 1951 and 7 October 1953 during which time KUCI was recruited and briefed by the Sigurini in Vlone, Albania. KUCI was to contact all of his friends abroad, work himself into the HXHEIN and spy on the Allied Services. KUCI was to go to Greece, and proceed to Italy and eventually to the U.S.A.

He was instructed specifically that friend Hasan DOSTI was to be contacted.
