1. DR. KRUNOSLAV (OCCASIONALLY REPORTED AS DRAGOMIR) DRAGANOVIC IS WELL KNOWN CROAT CATHOLIC PRIEST, FANATIC PAVELIC SUPPORTER WHO SINCE 45 HAS USED CHURCH INSTALLATIONS, FACILITIES AND INFLUENCE TO HELP USTASHA AND NAZI EMIGRES FIND SAFE HAVEN OUTSIDE EUROPE PARTICULARLY IN ARGENTINA. COMMUNIST AND CRYPTO-COMMUNIST PRESS HAS REPEATEDLY BLOWN HIS ACTIVITY.

2. IN PAST YEAR HAS BEEN CHARGED WITH BEING RIS AGENT, BY GERMAN EMIGRE FRITZ LANGE WHO RELATED THIS TO ARGENTINE AUTHORITIES. LOCAL POLICE SOURCES INCLINED TO ATTRIBUTE CHARGE TO PERSONAL REPRISAL OF PROVOCATION BY D'S POLITICAL ENEMIES, IN VIEW HIS PRECEDENTS. D IS DISTRUSTED BY ITALIAN C.E. WHICH BROKE OFF WITH HIM AFTER INITIAL CONTACT; THIS NOT DUE HIS POLITICAL BONA FIDES BUT FEAR HE WOULD NOT COOPERATE FULLY IF HIS FACTION'S INTERESTS NOT INVOLVED.

3. OPERATES INTELLIGENCE NET COLLECTING INFO IN ROME AND TRIESTE, EITHER THROUGH AGENTS OR DIRECT INTERROGATION OF REFUGEES. THIS MAY PROVIDE CLUE HIS INTEREST IN AMBROZ.
