MEMORANDUM FOR: Director of Central Intelligence

SUBJECT: Request for the Addition of [] to the FY 1954 Budget of Project DTLINEN (Subsidy to the Fighting Group Against Inhumanity in Berlin) Amendment No. 1

REFERENCE: FRAN 6957 (IN 42673)

1. The purpose of this memorandum is to request that [] be added to the FY 1954 budget ([] of Project DTLINEN (subsidy to the Fighting Group Against Inhumanity in Berlin). This increase, requested by the German Mission in reference cable, is needed to finance the special DTLINEN operations that will be carried out during the June 1954 Communist (FDJ) Youth Rally in Berlin. It is expected that over 400,000 East German youth will be in Berlin for the event and all appropriate German Mission projects are planning special operations in connection with the affair. The DTLINEN project is particularly qualified to participate in these special operations but will need the additional funds in order to carry out its assigned tasks. Since the FDJ Rally was not announced until October 1953 and the date and place were not officially selected until 5 March 1954, no provision was made in the FY 1954 budget for the exploitation of this event.

2. Funds are available in other EE Division projects and can be transferred to Project DTLINEN. The additional funds transmitted to the project will be accounted for in accordance with the DTLINEN administrative plan.
