1. C] REPORTING ORALLY TO SENATE ON DTLINEN 3 DEC, WILL STATE TO HIS KNOWLEDGE DTLINEN PRESENT ACTIVITIES WITHIN LEGAL FRAMEWORK AND THERE NO GROUND CONSIDER BANNING IT. WILL TAKE FEW POTSHOTS AT PREVIOUS FREEWHEELING BUT STATE THIS HAS CEASED. EVIDENCE SUPPORTING ANY CRIMINAL ACTS BY INDIVIDUALS SHOULD BE REFERRED STATE'S ATTORNEY IN LINE FOLLOWUP C] TRIAL. BELIEVE THIS TAKES CARE OF LEGAL ASPECTS INCLUDING ANY CHARGES PENDING AGAINST FORMER DTLINENERS FOR ACTS NOT CONNECTED ITS OPS.
2. C] BELIEVES RESPONSIBILITY FOR POLITICAL ASPECTS DTLINEN ANTI-COMMIE WORK LIES WITH FEDREP. ALTHOUGH HE DID NOT DIRECTLY STATE, BELIEVE C] FULLY BACKING BRANDT'S POSITION THAT BERLIN WEAK AND FEDREP STRONG SO THAT LATTER SHOULD TAKE LEADING ROLE COLD WAR.
