1. CARMANA ADVISES HAD LENGTHY TALK WITH LIPSCHITZ RE DTLINEN. LATTER STATED BELIEVES DTLINEN HAS OUTLIVED USEFULNESS AND SHOULD BE ALLOWED "DRY UP". ALSO EXPRESSED STRONG FEELING BOTH NEWHAM AND C SHOULD BE REPLACED, PARTICULARLY FORMER. CARMANA TOLD HIM WOULD AGREE RE LETTING DTLINEN "DRY UP" WERE IT NOT FOR REASONS OUTLINED BY C (SEE PARA 2 REF). CARMANA THEN MADE PITCH HAVE LIPSCHITZ ADOPT SIMILAR POSITION. CARMANA NOT SURE HE SUCCEEDED (~~PORTION CARRIED BEING SERVICED~~) ALTHOUGH THIS NOT CLEAR SINCE LIPSCHITZ KEPT SAYING THAT DECISION UP TO BONN AUTHORITIES.

2. CARMANA GENERALLY CONCURS PARA 2 REF POSITION AND CAN ALMOST CERTAINLY BE DEPENDED UPON TO FOLLOW THIS LINE IN FUTURE TALKS WITH VARIOUS BERLIN OFFICIALS.
