1. DISCUSSED REF DEVELOPMENTS WITH SIEGLERSCHMIDT WHO STATED FLATLY THAT INFORMATION QUOTED IN NEWSPAPERS MUST COME FROM ENQUETE REPORT. HE INVESTIGATING FURTHER. IN SEPARATE DISCUSSION LATER GEFAELLER HAD SAME OPINION AND BELIEVED THAT LEAK WAS DEFINITELY IN BRLN SENATE. GEFAELLER STATED FURTHER THAT THIS INCIDENT WAS ONLY PART OF ALL CONFLICT NOW BEING LAUNCHED BY PROPONENTS NEUTRALIST/CO-EXISTENCE COURSE.

2. DURING CHANCE MEETING 27 FEB [] TOLD [] THAT SPD BUNDESVORSTAND ANXIOUS TURN WESTFAELISCHE RUNDSCHAU ARTICLE INTO SUSTAINED ATTACK VS DTLINEN. STATED INFO CAME FROM BONN (SIC) AND IMPLIED SPD PRESSE DIENST INVOLVED. TOLD

[] HE HAD VOICED STRONG OBJECTIONS TO PROPOSAL. STATED HE UNAWARE CARMANA REACTION BECAUSE CARMANA CURRENTLY UNAVAILABLE.

3. EAST GER PRESS FEATURING STUDIES ON COOPERATION BRANDT/TILLICH IN ORGANIZATIONS SUCH AS KULTURELLE HILFE SOME YEARS AGO.
