1. CONSIDER DEVELOPMENTS INDICATED PARAS 1, 2 REF SUFFICIENTLY CRITICAL MERIT CONSIDERATION FOLL COURSE ¹ INTERACTION:

A. SINCE CAWASH LIPSCHITZ AND KUBARK AT THEIR REQUEST AGREED KNOWLEDGE RESULTS ENQUETE INVESTIGATION WOULD BE RESTRICTED LIMITED NUMBER OFFICIALS WITHIN ¹ CAWASH BERLIN GOVT, SUSPECTED LEAK FROM WITHIN BRLN SENATE REPRESENTS BREACH AFORECITED AGREEMENT. THEREFORE URGE WE GIVE FULLEST ENDORSEMENT SIEGLERSCHMIDT AND OR CAWASH INVESTIGATION THIS MATTER, AND IRRESPECTIVE WHO ULTIMATELY RESPONSIBLE FOR LEAK, SUGGEST STRONG KUBARK PROTEST VIOLATION THIS SECURITY AGREEMENT BE MADE TO CAWASH AND BRANDT/LIPSCHITZ.

B. WHILE WE FULLY COGNIZANT REALITIES POLITICAL LIFE FEDREP BERLIN, FEEL WE SHOULD NOT SIT IDLY BY SPEDERS PLANNING FULL SCALE ATTACK DTLINEN. LATTER HAS NOT TRANSGRESSED INTO POLITICAL ARENA IN ANY WAY SINCE EARLY 1955 AND FEEL KUBARK CAN GUARANTEE WILL NOT DO SO IN FUTURE. SINCE WE THINK IT HIGH TIME SPD STOPPED LIVING IN PAST, ONLY REAL VALID GROUNDS ON WHICH IT COULD ATTACK DTLINEN WOULD FALL WITHIN CONTEXT ITS CURRENT SOVZONE ACTIVITIES. THERE BASICALLY AND ESSENTIALLY SAME AS CASKS AND THOSE OTHER GROUPS CONDUCTING "AUFKLAERUNGS"

 PARED WATCH SPEDERS TORPEDO DTLINEN OUT FROM UNDER US, SUGGEST WE TALK BLUNTLY
 WITH OLLENHAUER HEINE, INFORM THEM KUBARK WOULD REGRET SEE SPEDERS BECOME IN-
 VOLVED ANTI DTLINEN CAMPAIGN, AND REQUEST THEM EXERCISE THEIR INFLUENCE SQUELCH
 IT. WE SUGGESTING DIRECT TALKS WITH OLLENHAUER HEINE BECAUSE (1) EVEN THOUGH WE
 EXPECT CARMANA WOULD BE SYMPATHETIC OUR POSITION ON DTLINEN IT UNLIKELY HE COULD
 DO MUCH DISSUADE ANTI DTLINEN SPEDERS FROM ACTING NOR SHOULD WE ASK HIM JEOPARDIZE
 HIS POSITION THROUGH DEFENSE DTLINEN AND (2) PAST EXPERIENCE IN TAKING UP SIMILAR
 PROBLEMS SOLELY WITH HEINE ALMOST ALWAYS RESULTED IN REPLY THAT HE COULD DO NOTHING
 SINCE NEITHER HE NOR SPD FOLLOW PRACTICE CENSORING OUTPUT SPD CONTROLLED OR ORIENTED
 PAPERS. IN ORDER CONVEY CLEAREST IMPRESSION SERIOUSNESS WITH WHICH KUBARK
 REGARDS MATTER, PROPOSE [5], AS ALLEGED HQS SPOKESMAN, AND [6] PARTICI-
 PATE IN MEETING. //

2. SUGGEST FURTHER THAT [7] PREPARE MEMORANDUM ON MAJOR MFS HARASSMENT
 ACTIVITIES DIRECTED AT DTLINEN PERSONNEL DURING PAST YEAR. BELIEVE THIS MIGHT
 BE EXCELLENT WAY REEMPHASIZE TO CAWASH AND BRLN GOVERNMENT OFFICIALS FACT THAT
 SOVZONE GOVERNMENT MORE THAN EVER CONSIDERS DTLINEN HIGHLY SUCCESSFUL OPPONENT TO
 BE ERADICATED AT ALL COSTS. FROM THIS IT FOLLOWS IT CERTAINLY NOT OPPORTUNE TIME
