B. FRAN 4989 (IN 38307) (PARA 1 A)

1. AFTER EXTENSIVE CONSULTATION WITH THEDIECK 4 MARCH, DELLINGSHAUSEN ADVISES FOLLOWING RE CURRENT STATUS DTLINEN:

A. AS PREVIOUSLY REPORTED, THEDIECK CONTINUES FEEL WAY CAN BE FOUND PERMIT CONTINUATION DTLINEN ACTIVITIES PROVIDED NEWHAM TERMINATED AND WITH COVERT STAFF ORGANIZATIONALLY DEPARTED FROM DTLINEN PROPER. HE WOULD WELCOME BND BACK-STOPPING AND SPONSORSHIP COVERT APPARAT. THEDIECK APPEARS FIRMLY CONVINCED "POLITICAL NECESSITY" DICTATES NEWHAM MUST BE DROPPED AND DELLINSHAUSEN STATES THERE NO USE TRYING REASON WITH THEDIECK ANY LONGER ON THIS MATTER.

B. LATEST ANTI-DTLINEN PRESS ARTICLES (BRLN 6397 (IN 34618) (6404 (IN 34890))) SERVE HIGHLIGHT URGENT NEED RESOLVE DTLINEN PROBLEM SOONEST, PARTICULARLY DIS-POSITION NEWHAM. THEDIECK PRESSING FOR RESIGNATION NEWHAM EVEN BEFORE SETTLEMENT VARIOUS LEGAL SUITS IN WHICH HE INVOLVED. DELLINGSHAUSEN PRIVATELY FEELS, HOWEVER, NEWHAM ACTION CAN BE DRAWN OUT FOR SEVERAL MONTHS BY WHICH TIME HOPES SUITS WILL BE COMPLETED. FYI, THEDIECK DEPARTING 8 MARCH FOR APPROXIMATELY ONE MONTH VACATION SO THAT LATTER CAN BE DEFERRED AT LEAST UNTIL HIS RETURN EARLY APRIL.

DURING THEDIACK ABSENCE, DELLINGSHAUSEN URGES WE PREPARE SPECIFIC PROPOSALS, PREFERABLY IN WRITING, IN LINE OUR CONVERSATIONS BRLN 12 FEBRUARY WHICH CAN BE DISCUSSED WITH THEDIACK IMMEDIATELY AFTER HIS RETURN. AS ALTERNATIVE, DELLINGSHAUSEN WILLING BE BRIEFED US SO THAT HE CAN PREPARE POSITION PAPER FOR THEDIACK TO SERVE AS BASIS FOR NEGOTIATIONS. HE FEELS WILL NOT BE POSSIBLE STALL DECISION MUCH AFTER THEDIACK RETURN. ANY REALISTIC PROPOSAL, HE STATES, SHOULD PROVIDE FOR ²NEWHAM TERMINATION. ³] TRANSFER WOULD NOT PRESENT MAJOR OBSTACLE, PARTICULARLY IF ²BND NEWHAM TERMINATION.

D. RE PARA 1 ⁵BRLN 6530 (IN 37536), DELLINGSHAUSEN/THEDIACK SHARE OPINION BRLN SENAT SOURCE PRESS LEAKS. SPECIFICALLY, THEY CONVINCED GERMER CHIEF CULPRIT AND, SINCE HE SENAT OFFICIAL, LIKELY HE MAY HAVE GOTTEN ACCESS TO SENAT FILES AND DETAILS LIPSCHITZ 10 DECEMBER SENAT ¹DTLINEN BRIEFING. E. GEFELLER/BRLN HAS CUSTODY ONLY COPY ENQUETE REPORT AVAILABLE ALL-GERMAN MINISTRY BONN. ENQUETE HANDLED AS "GEHEIM" SO THERE LITTLE CHANCE IT COULD HAVE BEEN REMOVED FROM BRLN/MINISTRY FILES. WITH THEDIECK CONCURRENCE, DELLINGSHAUSEN REQUESTING GEFELLER REPRODUCE TWO EXTRA COPIES, ONE FOR MINISTRY/BONN FILES AND OTHER FOR BND/FOERTSCH WHO REQUESTED COPY NUMBER WEEKS AGO.

F. FOLLOWING PRELIMINARY INVESTIGATION HANS GEORG SCHULZ (AUTHOR ANTI-DTLINEN SPANDAUER VOLKSBLATT ARTICLE REPORT ³BRLN 6397 (IN 34618) INITIATED BY THEDIECK/DELLINGSHAUSEN, CASE NOW BEING TRANSFERRED TO BND FOR FURTHER ACTION DUE EVIDENCE INDICATING SUSPICIOUS EASTERN CONNECTION.

G. RE FRAN ⁷5013 (IN 38701), DELLINGSHAUSEN STATES DIE WELT ITEM NONSENSE SINCE FEDERAL INTERIOR MINISTRY NOT INVOLVED OR INFORMED DTLINEN AFFAIR. HE DOES NOT RULE OUT POSSIBILITY, HOWEVER, INTERIOR MINISTRY REPRESENTATIVE BRLN OR OTHER UNINFORMED OR MALICIOUS FEDGOVTOR BRLN OFFICIAL MIGHT HAVE DROPPED REMARKS TO JOURNALIST WHICH INSPIRED ITEM. RE PARAS 1A-D ABOVE, WE ADVISED DELLINGSHAUSEN KUBARK COULD NOT AGREE DROPPING NEWHAM AS THEDIECK DESIRED SINCE FORCING NEWHAM RESIGNATION BEFORE COMPLETION TRIALS WOULD PREJUDICE NEWHAM CASE AND, EVEN MORE IMPORTANT, WOULD GIVE EAST CHEAP AND EXPLOITABLE PROPAGANDA VICTORY. AGREED, HOWEVER VARIOUS ALTERNATIVE

¹SOLUTIONS DTLINEN IMPASSE SHOULD BE EXPLORED DURING THEDIACK ABSENCE AND SPECIFIC PROPOSITIONS READIED FOR HIS RETURN, WE REMINDED DELLINGSHAUSEN THAT LEMMER, AT PRIVATE MEETING WITH US 26 FEBRUARY, HAD AGREED NO ACTION SHOULD BE TAKEN AGAINST ²NEWHAM WHILE SUITS BEING PROCESSED. WE ALSO NOTIFIED DELLINGSHAUSEN THAT LEMMER, ON SAME OCCASION, HAD REITERATED PREVIOUS ASSURANCE HE WOULD REFRAIN FROM MAKING UNCOORDINATED PUBLIC STATEMENTS RE DTLINEN (SEE PARA ³BONN 6343 (IN 49110)). AT SAME TIME, LEMMER MADE CLEAR HE DID NOT WISH BECOME INVOLVED DTLINEN NEGOTIATIONS AND WOULD ABIDE BY ANY SOLUTION WORKED OUT WITH THEDIACK/GEHLEN/GLOBKE. LEMMER ALSO PROMISED DO ALL IN HIS POWER, INCLUDING INTERCESSION WITH WEHNER IF NECESSARY, PREVENT ¹DTLINEN FROM BEING RAISED BUNDESTAG ALL-GERMAN AFFAIRS COMMITTEE PENDING COMPLETION NEGOTIATIONS (SEE PARA 1 REF A.) DELLINGSHAUSEN WILL CONVEY FOREGOING TO THEDIACK. HE PRIVATELY EXPRESSED VIEW THEDIACK WOULD* NOT CONTINUE INSIST ON IMMEDIATE TERMINATION ²NEWHAM IF WE ABLE REACH EARLY AGREEMENT FUTURE DTLINEN STATUS.
