1. FOLLOWING CONFIRMS TELECON.

2. PARA 1 REF REFERS COVER MECHANISM DESIRED BY FEDREP PRESS/INFO OFFICE FOR ITS SUBSIDY COLOGNE CLUB IN EVENT ITS BUDGET APPROVED. SEE PARA 3 EGBA 49071. WE AWARE DETAILED PLANS AND HAVE DRAFT BY-LAWS. INTENDED HAVE NO OFFICIAL POSITON BUT CONTINUE INFORMAL COORDINATION AS HE HAS BEEN DOING IN COLOGNE CLUB. DESIREABILITY THESE LATTER INFORMAL GET-TOGETHERS ENDORSED BY GLOBKE IN RECENT TALK WITH KLAUS DOHRN. WE CONSIDER THAT FEDREP FUNDING COLOGNE CLUB NOT UNDESIRABLE SINCE (A) WOULD PERMIT US WITHDRAW WITHOUT RAISING POLICY QUESTIONS OUTSIDE KUBARK AND (B) FEDREP VENTURES INTO INTERNATIONAL PSYCH WAR COULD BE BETTER MONITORED THROUGH GROUP IN WHICH WE ALREADY HAVE KUBARK AGENT REPRESENTATION.

3. PRIOR TO RECEIPT REF WE DISCUSSED WESTERN ACTIVITIES WITH AND ADVISED HIM THAT HE SHOULD TAKE NO POSITION NOR PLAY ANY ROLE IN ANY NEW ORG WHICH MAY BE FORMED IN NEAR FUTURE. SINCE THEN AND IN VIEW RESULTS 15 APRIL MEETING WITH THE DECK, WE REVIEWED SITUATION WITH AND ARRIVED

FOLLOWING DECISIONS.

A. AT MEETING INNER CIRCLE 20 APRIL HE WILL ANNOUNCE WITHDRAWAL ACTIVE PARTICIPATION IN COLOGNE CLUB AND ANY SUCCESSOR ORG. WILL ALSO INDICATE RESIGNING FROM DTLINEN IN NEAR FUTURE. C. AT SAME TIME, [] WILL BE REMOVED FROM OVERT ACTIVITY INCLUDING ANY SUPERVISION OF STAMMHAUS. ALTHOUGH HE MUST RESIGN SHORTLY ALSO, HE STILL NEEDED TIE UP NUMBER OF LOOSE ENDS. WE ALSO WISH GAUGE EFFECT ON CURRENT ANTI-DTLINEN CAMPAIGN OF [] RESIGNATION.

D. [] WILL ASSUME DIRECTION DTLINEN FOR TIME BEING, ASSISTED BY ALIAS JUST AND ALIAS GABLER (IDEN 1 AND 2).

ANY ATTEMPT CANCEL HANNOVER MEETING WOULD HAVE REQUIRED NOTIFICATION 20-30 INDIVIDUALS THROUGHOUT WESTERN EUROPE AND WOULD HAVE INITIATED INNUMERABLE UNCONTROLLED RUMORS AND SPECULATIONS AS TO CAUSE FOR CANCELLATION INEVITABLY FOCUSING ON KUBARK DIRECTION [] , KUBARK ROLE IN COLD WAR GENERALLY.
