IN LINE 27 JANUARY DISCUSSIONS FEEL THAT PLAYING DTLINEN TERMINATION LOWEST POSSIBLE KEY REMAINS MOST DESIRABLE COURSE AND STRONGLY PREFER NO INITIATIVE BY ANY GERMAN OFFICIALS OPENLY ANNOUNCE TO PRESS. LIPSCHITZ AND OTHER GERMAN OFFICIALS WILL UNDOUBTEDLY GET THEIR CHANCE COMMENT ONCE NOTICE TERMINATION DTLINEN FILED WITH COURT AND LABOR OFFICE. HOWEVER EVEN THEN WOULD HOPE SUCH COMMENTS WILL BE TAILORED WITH OVERALL BERLIN SITUATION IN MIND BY AVOIDING GREATEST DEGREE POSSIBLE STATEMENTS WHICH EXPLOITABLE BY EAST OR WHICH SEEM INDICATE THIS FIRST RESULT EAST ANTI-SPY CAMPAIGN.
