1. SAW SIEGLERSCHMIDT 1500 19 FEBRUARY TO MAKE CLEAR THAT MAJOR POINT OVERLOOKED IN SENAT MINISTRY CONTROVERSY AND LIPSCHITZ DESIRE MAKE OPEN PRESS ANNOUNCEMENT WAS OUR OPERATIONAL SITUATION I.E. THAT DTLINEN EMPLOYEES APART BEIRAT NOT YET OFFICIALLY AWARE IMPENDING TERMINATION AND THERE VARIOUS TECHNICAL REASONS WHY INTERNAL DTLINEN ANNOUNCEMENT AT THIS TIME UNDESIRABLE.

2. SIEGLERSCHMIDT WHO LEAVING TOWN 19 FEB PROMISED BRIEF LIPSCHITZ PRIOR HIS DEPARTURE. SIEGLERSCHMIDT REASONABLY SURE LIPSCHITZ WILL HONOR OUR POSITION. THINKS LIPSCHITZ MAY WITHDRAW SENAT FROM PRESENT EXERCISE BECAUSE OPPOSED CONFIDENTIAL BACKGROUND BRIEFING CONCEPT, PARTICULARLY IF ANY CONNOTATION PRESS MUZZLING INVOLVED. SAID LIPSCHITZ WOULD UNDOUBTEDLY DESIRE MAKE PUBLIC PRESS STATEMENT EARLIEST POSSIBLE DATE SUITABLE OUR OPERATIONAL CONVENIENCE. WE INDICATED TIME OF VEREIN MEETING MIGHT WELL BE EARLIEST POSSIBLE DATE, BUT THAT MATTERS MIGHT BE SUFFICIENTLY ALONG SOMEWHERE BETWEEN THE TIME NOTICES CALLING MEETING SENT AND MEETING ITSELF.

3. COMMUNICATED ABOVE TO REHLINGER WHO PROMISED KEEP US CURRENTLY INFORMED FURTHER DEVELOPMENTS. APPEARS REASONABLY SURE COMBINATION USBER
