1. KELL AFTERNOON 4 MARCH SAID BERLIN OFFICE HAS HAD NO WORD FROM MINISTRY RE FUTURE OF SEARCH SERVICE. WHILE KELL AWARE SATTLER VISIT TO DTLINEN WITH RED CROSS TEAM 27 FEBRUARY, SATTLER LEFT NO WORD MINISTRY INTENTS.

2. DTLINEN PERSONNEL WHO TALKED SATTLER 27 FEBRUARY NOT ABLE DISCERN POLICY INTENT BEHIND SATTLER VISIT. ONLY CONCRETE DEVELOPMENT WAS STATEMENT RED CROSS OFFICIALS THAT SEARCH SERVICE DATA QUITE VALUABLE. (confirmed)

3. [] WENT BOND 5 AND 7 MARCH AT SATTLER REQUEST. * ALSO TALKED DELL-INGSHAUSEN. [] GAINED CLEAR IMPRESSION THAT (A) DELLINGSHAUSEN PITCH THAT MINISTRY TAKE OVER SEARCH SERVICE OVERRULED BY HIS SUPERIORS (B) SEARCH SERVICE FILES PROBABLY WILL BE GIVEN RED CROSS HANDS (C) MINISTRY BELIEVES IT CAN GET RED CROSS ALSO TAKE 2 SEARCH SERVICE EMPLOYEES, ONE OF WHOM WOULD BE DTLINEN 5.
