Paragraph 2 of FRAM 3799

1. On 7 April [] [] [] met in the latter's apartment for a business lunch. Following is a summary of the discussions of various matters of mutual interest:

2. DELINEW:

a. We raised the still unsolved problem of the continuation of payments for dependents of arrested co-workers after the liquidation of DELINEW. On the basis of an informal memorandum (now Attachment "B" to MEBA-56376) by [] which [] had obtained from BOB and the substance of which he passed to [], we pointed out that roughly 80-odd cases are involved, of which about forty concern people in West Berlin or West Germany. The remaining cases are those of people in East Berlin or East Germany who have, in the past, received the support payments either through changing DEW's into DEW's and infiltrating this money into the East Zone through a cut-out, or by personal monthly or quarterly appearances of dependents in West Berlin. We explained further that the wife of I [] has expressed a willingness to continue handling these support payments in the future, but that this solution depended upon the decision as to what job [] would obtain. In this connection we mentioned that according to I [] and contrary to [] previous statement, I [] had not been offered a position by IDENTITY-1. [] replied that I [] had indeed been offered a position by IDENTITY-1 but had turned it down unless all personnel of his section were similarly taken care of. [] also repeated that payments to West Berlin and West Germany could be handled by IDENTITY-1, but that payments eventually ending in the East Zone could not be handled by that institution because of possible reverberations in its relationship with its counterpart in East Germany. [] however, thought that an unofficial West Berlin charity organization could perhaps be found to assume the responsibility for these payments. We stated that we would be willing to transfer a lump sum covering the payments for one year (per DIR 14465). Once this fund is exhausted, there would be no further payments from us, since we felt that by then we would have more than fulfilled our moral obligations. We ended with [] promising to discuss this whole matter further with IDENTITY-2.

b. We informed [] that the liquidation of DELINEW was proceeding apace and that a liquidation office for [] had been established. [] inquired as to the status of the legal charges against DELINEW, [] et al. We advised that they still presented a formidable problem, the solution of which is not yet in sight. (KE: BOB and [] have just completed the first draft of a paper briefing the background and nature of these charges and containing recommendation for action. It will be forwarded as soon as it has been fully coordinated and approved by []. We might add right now though that there exists no easy solution and the ghosts of the past will be resurrected to some degree.) In this connection [] mentioned that a spate of rumors is circulating that IDENTITY-3 is basically a continuation of DELINEW under a new label and sponsorship. The basis for these allegations is the fact that quite a number of former members of [] former small circle have been founding members of IDENTITY-3 and are actively working on its behalf.
