Reference A transmitted a report prepared by [] in his capacity of liquidator of the DITLINEN Verein, tracing the administrative and legal measures taken through 10 June 1959 in implementation of the decision to terminate the DITLINEN organization. Under separate cover, we are transmitting [] final report, dated 16 May 1960, on the liquidation and final legal dissolution of the DITLINEN Verein. The report, which recapitulates the ground covered in [] first report, summarizes developments during the entire one year statutory period of legal liquidation, 1 April 1959 to 20 April 1960. (As noted in Reference B, final legal extinction of the DITLINEN Verein was delayed by approximately three weeks due to the necessity first to obtain out of court settlement of a civil legal action still pending against the Verein.)</p> <p>2.
