1. Charles E. Newham was to see a representative of Identity A in WSCORNY at the end of last week in the hope of establishing a regular channel for the receipt by DTLINEN of material such as BGEAGLES. Newham has received various BGEAGLE (and other QKFENCE material, including recent Identity A stickers) in the past; at the end of January DTLINEN reported 400 H-12 on hand for distribution before any had been passed by us.

2. Since Newham is now out of town, we will not have a report on this meeting until sometime next week. However, if the possibility exists of establishing a non-staff transfer channel on a more regular basis, we much prefer that material be transferred in this way in the future. This is based not only on staff transport problems (which, however, we naturally prefer to avoid) but more important on the security risks involved in large-scale transfers in WSCORNY between staff and agent personnel.

3. In answer to Reference 1., therefore, we prefer to take no more material until Newham's report is received and a long-term decision made.

4. For your records, we picked up 9,200 (23 packages of 400 each) of H-12 in January, not the 5,000 each of H-12 and H-13 which you mention. Twelve packages of these were turned over to DTLINEN on 13 February and the remaining 11 will be passed to them in the near future.

5. New subject: LCPAGAN. Several weeks ago, while investigating the possibilities of increased LCPAGAN distribution, [] discovered that HBALLOT has been receiving 3-4,000 copies regularly each month. We have rechecked DTLINEN and PBBLOOM distribution reports and are reasonably convinced that neither could be the source of so large a sub-allocation. [] last week contacted [] of HBALLOT who informed him that they were received from Identity A in DTDAILY along with other BQFLUME material. If this is true, it means that a considerable amount of the shipment which we bring to DTDAILY is being reshipped to WSCORNY for distribution.

6. We have no indication of who is "representing" Identity A. Would you please check this at your end and if KIBELLE has been shipping LCPAGANS to WSCORNY, request that they distribute them only from DTDAILY in the future.

7. If such a change requires a reduction in our shipments to you, please let us know as soon as possible. Unless we hear from you to the contrary, we will continue to deliver to you at a regular rate of 15,000 monthly, usually at the beginning of each month. We are submitting a request to the Home Office for increasing total production so if you should want a larger figure, we could probably increase it, up to 20,000, after about two months.

8. In answer to reference 2., the bad wrapping last month was a result of the shift to the PEBLOOM printing plant, with new packaging people. The shipment was sent down to you immediately after delivery; otherwise the packages would have been rewrapped here. [] has been instructed to check personally from now on that they are properly wrapped for shipment, and letter designations will be added by us.
