SUBJECT: Amendment No. 2 to Revised Administrative Plan for
IC Division Proprietary Project DTPILLAR

I. Objective and Instrumentality

1. The objectives of DTPILLAR are to promote the development of leaders in the fields of politics, education and religion and to provide the organizational instruments and resources through which such leaders may be developed. DTPILLAR is an ostensible eleemosynary organization, incorporated under the laws of the State of California.

II. Background

2. In April 1951, KENDRICK initiated Project DTPILLAR to aid in the creation of private action institutions and groups in Asia which would provide expanding opportunities for Asians and thus counteract the appeal of Communism. DTPILLAR has won widespread recognition and acceptance in Asia and is now represented in every Far Eastern nation from KOREA through Afghanistan except Laos and India - where programs are administered from neighboring countries or headquarters.

III. Need for Amendment

3. Amendment No. 1, approved 24 January 1958, authorized a change in fiscal year for the project from 1 July - 30 June to 1 August - 31 July. Amendment No. 2, attached, establishes a reserve fund for DTPILLAR as proposed in the 1959 budget submission. Under date of 25 June 1958, the PRG recommended to the DCI that he approve the budget as submitted. The special fund will be entitled "President's Reserve Fund," will amount to [] and will replace the current contingency fund of []

IV. Approvals

4. The approved allotment for FY58 amounted to \$4,000,000, which was amended by project action under date of 27 June 1958 to include an additional [] for the transitional period in change of fiscal years. The current FY59 request amounts to []

Amendment No. 2

DTFILLAR

1. Amend paragraph 13 of the Administrative Plan for DTFILLAR approved 13 September 1957, to read as follows:

"13. A "President's Reserve Fund" may be provided by the Agency as an integral part of the annual budget for this project, and shall be shown as a separate line item in such budgets; shall be nonreplaceable during each fiscal year; and shall not exceed \$300,000. The "President's Reserve Fund" may be used to the extent of not more than \$100,000 for the purpose of exceeding any budget limitations prescribed by the Agency for activities which have been presented for approval, or it may be used on an emergency basis without restriction as to total amount to implement new activities not contemplated in the approved budget, provided that authorization for each such new activity or for any use of the "President's Reserve Fund" in an amount which will exceed any single budgetary limitation by more than \$25,000, is received by DTFILLAR in advance from the Chief, IC Division or his designee, and provided further, that any use of the "President's Reserve Fund" shall be reported in writing to the IC Division within five days thereafter. The IC Division will advise the Budget Division of the use of the "President's Reserve Fund" through the submission of monthly accountings."
