1. AMIN SHAKIR ASKED RABBI BERGER THROUGH [] FOR BERGER VIEW OF PROPAGANDA IMPLICATIONS OF EICHMANN CASE AND WHETHER BERGER WILLING ADVISE GUAR ON PROPAGANDA TO COUNTER. BERGER REPLIED BY LETTER THROUGH [] FOR SHAKIR THAT ZIONISTS WILL USE CASE TO CONDEMN UAR FOR HARBORING OTHER NAZIS AND HE WILLING ASSIST UAR BY COUNSELLING ITS COUNTER PROPAGANDA. SHAKIR NOW TELLS [] THAT NASIR WILL THIS WEEK DECIDE NATURE OF GUAR COUNTER PROPAGANDA CAMPAIGN AND DEGREE TO WHICH BERGER TO BE USED IN IT. SHAKIR ^{SAYS} ~~SAYS~~ EVEN POSSIBLE BERGER WILL BE INVITED COME CAIRO. SHAKIR MEANWHILE HAS ASKED FRENETTE TO WRITE AGAIN TO BERGER AND ASK FOR DATA ALSO ON LAVON CASE. LETTER UNTIL HQS ADVISES WHAT WANTED.

2. PARENTHETICALLY, STATION HAS NOTED SEVERAL RECENT ARTICLES, ONE IN NEW YORK TIMES, NAMING GERMAN "WAR CRIMINALS" HARBORED UAR. MOST RECENT ARTICLE IS 14 OCTOBER NATIONAL JEWISH POST AND OPINION. LEADING "CRIMINAL" THIS ARTICLE AS OTHERS IS UPHILLER KRUSIUS.

3. REQUEST ADVICE WHETHER THERE KUCAGE ROLE FOR STATION IN THIS BERGER-SHAKIR DEAL. NOTE THAT INDICATIONS THUS FAR ARE THAT COMMUNICATIONS BETWEEN THEM WILL CONTINUE BE HANDLED THROUGH WE THEREFORE ABLE INSERT MATERIAL EITHER WAY.
