1. UTILITY GAVE C CITE 30 DECEMBER COPIES 15 DECEMBER LETTER FROM GERMAN ATTACHE MADRID ADDRESSED GEN WESSEL GERMAN J-2. MA WROTE THAT OTTO SKORZENY 15 NOVEMBER REQUESTED CERTIFICATION FROM A GERMAN INTEL SERVICE OFFICE THAT HE NOT INVOLVED SPIRITING EICHMANN AUSTRIA TO SPAIN 1948 AS REPORTED "SEE" MAGAZINE. (NOT CLEAR WHETHER SEPT OR NOV ISSUE.) WHEN MA TOLD SKORZENY NEITHER HE NOR GERMAN EMB COULD OBTAIN CERTIFICATE, SKORZENY ASKED MA 5 DECEMBER FORWARD LETTER TO UTILITY.

2. SKORZENY LETTER (COPY OF WHICH WE HAVE) STATES FRIENDS IN PBPRIME SENT HIM COPY "SEE", THAT HE COULD NOT BELIEVE WEST GERMAN INTEL OFFICER HAD GIVEN STUPID AND SLANDEROUS INFO AND STUPIDITY EVIDENT SINCE SKORZENY STILL IN DARMSTADT DENAZIFICATION CAMP.

4S AND DID NOT COME SPAIN UNTIL NOVEMBER 50. IN ORDER BRING AUTHOR BELA VON BLOCK TO COURT SKORZENY ASKS UTILITY FOR SOME SORT OFFICIAL CHARACTER TESTIMONIAL FROM WEST GERMAN INTEL SERVICE ESPECIALLY CONCERNING ALLEGATIONS.

3. ATTACHMENT SKORZENY LETTER IS EXTRACT FROM "SEE" ARTICLE.

GIVES VON BLOCK ODOYKE PASSPORT NUMBER 307 410 AND ADDRESS AS CALLE DELLA MISERICORDIA 358A VENICE ITALY.

4. UTILITY FEELS OBLIGED REPLY SKORZENY AND WANTED COORDINATE WITH US BECAUSE KUBARK MIGHT HAVE OPS INTEREST IN HIM. STATED HE WAS AWARE CONTACT WITH [ ] AND SINCE SKORZENY REPORTEDLY IN CONTACT WITH EGYPTIAN INTEL SERVICE PERHAPS [ ] USING HIM AS DA. IF SO UTILITY NOT INTERESTED IN OPS DETAILS.

5. UTILITY FELT CERTIFICATION CONCERNING DARMSTADT INTERNMENT WOULD HAVE TO COME FROM AMERICANS. UTILITY NOT ANXIOUS PROVIDE SKORZENY WITH LETTER OR AFFIDAVIT SINCE HE LIKELY TO USE IT AS ALLEGED EVIDENCE OF CLOSE CONNECTION WITH UTILITY.

6. UTILITY REQUESTS ANY INFO BELA VON BLOCK AND WHETHER THERE POSSIBLY ANY BACKGROUND FOR VON BLOCK ARTICLE IMPLICATING SKORZENY. HE FURTHER REQUESTS SKORZENY NOT LEARN OF UTILITY DISCUSSION THIS MATTER WITH US.

7. UTILITY WAS TOLD THAT [ ] [ ] HAD HAD SOCIAL CONTACT WITH SKORZENY BUT WE VERY DUBIOUS ANY OPS INVOLVEMENT. ALSO THAT WE NOT FAMILIAR WITH SEE MAGAZINE BUT PERHAPS IT SPECIALIZES THIS TYPE STORY. UTILITY THOUGHT HE MIGHT REPLY SKORZENY THAT MAGAZINE MERELY SCANDAL SHEET.
