1. AT CHANCELLORY REQUEST UPHILL² PREPARING STUDY ON SOVIET EXPLOITATION EICHMANN CASE. SPECIFIC TITLE STUDY NOT YET KNOWN BY US BUT THIS IS GENERAL SUBJECT.

2. APPARENTLY UTILITY¹ WHILE IN BONN ORDERED STUDY TO BE MADE BY ALIAS WINTERSTEIN⁵ 21 FEBRUARY. UPHILL² NOW FEVERISHLY PREPARING AND TRANSLATING INTO ENGLISH. WE WILL HAVE OPPORTUNITY CHECK TRANSLATION LATE 22 FEBRUARY.

3. HARTWIG FIRST REQUESTED THAT WE CABLE HDQS ENTIRE TRANSLATION (STUDY REPORTEDLY ABOUT 20 PAGES) TO INSURE ARRIVAL BY TIME ALIAS DR OTTO GETS TO WASHINGTON. HE LEAVING BY LUFTHANSA JET 23 FEBRUARY TO HANDCARRY STUDY AND ATTACHMENT TO ALIAS KUEHNE⁷ WHO WILL REQUEST APPOINTMENT WITH ASCHAM FOR 24 FEBRUARY. OTTO⁶ ACTING ONLY AS COURIER AND NOT EXPECTED MEET WITH KUBARK.

4. FURTHER INDICATION CRASH BASIS THIS MATTER BEING HANDLED BY UPHILL² IS FACT OTTO⁶ DID NOT KNOW UNTIL 21 FEBRUARY THAT HE TO FLY WASH. DOES NOT EVEN HAVE ODYOKE VISA YET WHICH EXPECTS OBTAIN MORNING 23 FEBRUARY JUST PRIOR CATCHING PLANE.

5. THUS FAR WE HAVE NOT BEEN ABLE LEARN WHAT THIS ALL ABOUT.
