1. ALIAS DR OTTO DEPARTED MUNICH 1200 HOURS 23 FEBRUARY FOR WASH. HE HANDCARRYING UTILITY LETTER TO ASCHAM, SIX COPIES STUDY IN ENGLISH ENTITLED "EICHMANN TRIAL EXPLOITED FOR DEFAMATION CAMPAIGN AGAINST FEDREP BY EASTERN PROPAGANDA AND AGITATION".
2. LETTER EXPLAINS UTILITY ORDERED BY CHANCELLORY FORWARD STUDY TO ASCHAM. GLOBKE ISSUED ORDER BUT WHEN QUERIED SPECIFICALLY UTILITY EXPLAINED THIS JUST NOT GLOBKE'S IDEA BUT UPTHURSTS.
3. UTILITY APOLOGIZED FOR LETTER TO ASCHAM WHICH DRAFTED HURRIEDLY MORNING 23 FEBRUARY UPON UTILITY RETURN FROM BONN. HE ALSO COMMENTED ON HIS PERSONAL REMARKS ABOUT GLOBKE IN LETTER SAYING LATTER MIGHT NOT APPROVE HIS HAVING MADE THEM. HOWEVER UTILITY CONSIDERS GLOBKE

4. AS UTILITY LETTER POINTS OUT PURPOSE EICHMANN STUDY ONLY TO
SHOW EASTERN DEFAMATION CAMPAIGN AGAINST FEDREP. UTILITY GAVE NO
ADDITIONAL REASONS WHY FELT IT NECESSARY USE DR OTTO AS COURIER ON
SUCH URGENT BASIS. HE MADE IT CLEAR THAT IT NOT INTENDED THAT OTTO SEE
ASCHAM (KUEHNE TO DO THIS) AND THAT OTTO REALLY NOT FAMILIAR WITH
STUDY WHICH BEST OUR KNOWLEDGE ACTUALLY PREPARED BY ALIAS WINTERSTEIN.
WHEN ASKED UTILITY SAID HE DID NOT HAVE IN MIND ANY
REQUEST THAT KUBARK ASSIST IN COUNTERING EASTERN CAMPAIGN.

5. OTTO ALSO CARRYING COPY UPHILL REPORT ON KHRUSHCHEV BRIEFING
DDR ECONOMIC DELEGATION EARLY FEBRUARY ON WORLD SITUATION. WE WILL
MAKE NO FIELD DISSEM BUT WILL FORWARD COPY COS.

6. ALTHOUGH UTILITY DID NOT INTEND THAT OTTO MEET WITH KUBARKERS
OR RECEIVE BRIEFINGS HE HAS NO OBJECTIONS. RECOMMEND THAT DESPITE
SHORT NOTICE YOU ARRANGE SOME BRIEFING. HIS MAIN RESPONSIBILITY IS
TO SCREEN UPHILL REPORTS FOR DISSEM WITHIN HBGROPING. HE ALSO PROCESSES
