

Honorable Sir:

I am enclosing herewith a copy of a letter containing complete information concerning the war criminal Adolf Eichmann (who has previously been referred to as Karl Eichmann), which was sent to Dr. Nahum Goldman, President of the Jewish Agency, by Simon Wiesenthal of Linz, Austria. The letter is in German. After translation of the same, you will readily agree that all the facts and reports previously forwarded you concerning Eichmann have been substantiated.

Adolf Eichmann's philosophy of life is the destruction of democracy, create friction and the annihilation of the Jewish people. His education and political career have been devoted to the above. He was one of the important Nazis responsible for the barbaric extermination of six million Jews in Europe. His very existence is a menace to the free world. The most stringent steps should be taken to bring him to justice.


There are also enclosed two photostats of him and fifty-one photostatic copies of documents describing his notorious career. These were secured at great risk and should prove of invaluable aid to you. After you have made use of them, I would appreciate their return. It will be quite apparent from the examination of these documents to establish that Eichmann is alive and active; that he is a leader and working in conjunction with an underground group, which have never surrendered their Nazi ideals; and that he is fortified with tremendous resources of wealth to further his ambitions.

There is also enclosed another letter of Dr. Goldman giving the additional support to the report that Eichmann is presently in Syria. Needless to say, his purpose there is to foment Arabian discord against Israel and the free world.

It is quite evident from all of the reports I have forwarded you concerning this notorious character that his case is truly one of the most urgent to be dealt with. Otherwise, there can never be world peace.

As the head of the Central Intelligence Agency it is incumbent upon you to call attention to the State Department the consequences that can result from the shipment of military supplies to the Near East while men like Eichmann are in such predominant positions there, though it may be unofficial. It is further incumbent upon you as the head of the Central Intelligence Agency to call the attention of Eichmann's existence to the Bonn Government and request that legal action be taken by West Germany for his apprehension and trial.

I hope that you have no objection but I am forwarding copies of this letter to several members of Congress who have evidenced considerable interest in these endeavors.

I most respectfully hope that you will act accordingly.
