2. SUBJECT WAS TRACED PER REFERENCE AND NEGATIVE REPLIES WERE RECEIVED FROM COS, GERMANY, MID, OSI AND A-2. WE CAN FIND NO RECORD THAT HEADQUARTERS TRACES WERE RECEIVED.

3. SUBJECT'S CAREER HISTORY IS AS FOLLOWS-

1927	ABITUR IN JENA
1927-39	POLICE SERVICE IN GERA/THUERINGIA
1939	TRANSFERRED TO POLICE HEADQUARTERS IN DRESDEN
1940	TRANSFERRED TO THE GESTAPO
1941-42	POSSIBLY ASSIGNED FOR AN UNKNOWN PERIOD ON THE RUSSIAN FRONT HOWEVER EILITZ' FILE IN UPHILL CONTAINS HIS OWN STATEMENT THAT ON 1 OCTOBER 1941 HE WAS CANDIDATE POLICE INSPECTOR AND 'KRIMINAL OBER-ASSISTENT' IN AACHEN.
JUNE 1942- MARCH 1943	ATTENDED TRAINING COURSE FOR CANDIDATE KRIMINAL KOMMISSAREN AT BERLIN-CHARLOTTENBURG, SCHLOSS STRASSE 1. MET UJDROWSY AT THIS COURSE.

1943 KRIMINAL KOMMISSAR WITH RSHA/VI/C/13, NEAR EAST  
1945 GIVEN SPECIAL ASSIGNMENT BY THE RSHA TO TAKE CHARGE  
OF FOREIGN DIPLOMATS WHO WERE INTERNED IN THE  
BAYRISCHEN WALD NEAR DEGGENDORF.  
MAY 1945 RETURNED TO HIS FAMILY'S HOME IN STADTRODA WHICH  
WAS THEN STILL IN AMERICAN POSSESSION.  
JULY 1945 STADTRODA WAS OCCUPIED BY THE SOVIETS WHO WERE  
LOOKING FOR EILITZ. HE WAS ABLE TO HIDE OUT  
UNTIL DECEMBER 1945 WHEN HE FLED TO WEST GERMANY.  
1946-1956 EMPLOYED AS TRAVEL AGENT. RESIDED FOR UNKNOWN  
LENGTH OF TIME AT SOLTAU/HANNOVER, WILHELMSTR.  
19A. THEREAFTER HAD VARIOUS ADDRESSES.  
1956 RECRUITED FOR UPHILL ON UJDROWSY'S RECOMMENDATION.  
NOVEMBER RESIDES MUNICH, NAUPLIASTR. 66 WITH HIS MISTRESS  
1959-PRESENT: *called* CHRISTINE \* RICHTER WHO IS A REALTOR.

4. WE DO NOT KNOW IF UPHILL'S SUSPICIONS OF SUBJECT WERE  
ORIGINALLY BASED ON FACTORS IN ADDITION TO UJDROWSY'S ROLE IN SUB-  
JECT'S RECRUITMENT. ALIAS FLEMING, HOWEVER, HAS RECENTLY STATED THAT  
HE IS CONVINCED THAT THERE IS SOMETHING WRONG WITH SUBJECT. WE HAVE  
MAINTAINED CALLIKAK COVERAGE ON SUBJECT SINCE JULY 1962 AT UPHILL'S  
REQUEST.

5. MUNICH FILES CONTAIN NO TRACES IN ADDITION TO REFERENCE,  
THE NEGATIVE TRACE REPLIES THERETO AND EGMA-42709, 5 JULY 1957 WHICH  
FORWARDED SUBJECT'S BDC FILE.
