1. CENTREG advised that Alois BLUECHEL, [] was arrested on 2 May 1946 at Stadtsteinach for having been an Unterscharfuhrer in the SS Deathhead Brigade. At the time of his arrest, he was a tailor residing at Enchenreuth 73. WOMACE has no additional information on Subject.

2. The file on Rolf Botho Ernst ENGELS [] contains the following information in addition to that contained in reference:

a. A SHARY card on Subject stated that he had been a lorry driver and W/T agent trainer of Gruppe I 1 (secret commo) in KO (Kriegesorganisation) Portugal. First reported in I 1 in September 1943, he was posted to a KO Portugal reserve station near Bordeaux, France. In May 1944, he was transferred to Lisbon. In the course of his duties, he made frequent trips to Bordeaux and Paris transporting fuel.

b. A WOHIVE report dated 16 September 1944 stated that Rolf ENGELS, born 15 January 1908 in Cruiten (sic), held German Passport No. II 5248/43, issued 4 March 1944 in Berlin. On 4 September 1944 Subject received a Portuguese visa good for six weeks. He was then a German Legation employee (city not specified) who had either come from or was going to Buenos Aires.

c. Several WOHIVE documents which probably refer to Subject state that he left Portugal on 18 October 1944, but that in 1945, he was on the repatriation list of German IS officials or collaborators of the German Legation in Lisbon.
