Processing of [] Reports, Nos. 25-31 Inclusive

Ref: WUM-4-919; H W-7-493

- 1. All of the seven reports (Nos. 25-31) forwarded under the referenced covering dispatch were processed as follows:

This group of reports appeared to us to be especially useful. We encountered a little difficulty with the last sentence of paragraph 7, Report No. 21, where the intended sense was not quite clear to us. We believe that AFONAL wished to state that DIAZ was supposed to obtain FERNANDEZ's concurrence from time to time on which personalities of the Uruguayan Government were to be brought under attack. Actually, the sentence states they were to establish the attacking Uruguayan Government personalities. In view of the lack of clarity, we omitted the sentence in editing NAAG-650. We would be pleased to learn what the sense of the statement should be.

- 2. With reference to our comment in NAAG-1034, paragraph 4, regardless of whether AFONAL intended only to state that Fritz-E. EDENCKE would be in Buenos Aires at the same time as West German Minister of Economics ERHARD or would be a member of his party, his information has been confirmed to the extent that EDENCKE was actually in Buenos Aires at the same time, and was photographed with ERHARD at a function they both attended; the photograph appeared in the local press.
- 3. This Mission has taken cognizance of the queries posed by Headquarters in WUM-4-919. In view of the outcome of [] initial meeting with [] and the fact that [] is and must remain unwitting as far as [] participation is concerned, we find it impossible to make any recommendations

for change or improvement in the communications between [] and []
This represents no change in our view of the [] Project expressed in
HAAM-933, paragraph 5. Since [] is unwitting of any ODTOKS participa-
tion and in any event would be unwilling to cooperate with ODTOKS, no basis
is apparent for extending to [] the controls exercised over []
However, an intelligence audit could be helpful in determining whether the
information received is of sufficient value to warrant the continuance of
the [] link as a calculated risk. Since receipt of the first
group of reports, the production has increased quantitatively and improved
considerably in quality in the opinion of this Mission. During this period
we have been able to confirm some of the material received and have been
sufficiently convinced of the source's reliability to raise his evaluation
rating from F to B. Of 31 reports received, this Mission has disseminated
27 as useful intelligence. In view of this performance it is therefore
suggested that customer evaluations might be examined to establish the value
of the material produced by [] and [], prior to taking any action
that would deny ODTOKS this information. This Mission reiterates its desire
to continue receiving the [] material, but in view of the broad scope
of its coverage we feel that ultimately Headquarters is in a better position
to judge the value of this operation.
