SUBJECT { GENERAL Operational/REDWOOD/LCIA/PROVE/AECARTHAGE
SPECIFIC Memorandum of Oral Agreement with AECASSOWARY-6

1. In accordance with the terms of Basic Plan AECARTHAGE, AECASSOWARY-6 has been engaged under an oral contract by the undersigned case officer for an indefinite period. The effective date of this oral contract is 1 November 1956.

2. Compensation: Effective 1 November 1956, a monthly salary of 81.0 DM is to be paid to Subject.

3. Operational Expenses: During the period of contract, we will reimburse Subject for costs incurred by the operational requirements. These will include the following:

- a) Special operational equipment;
- b) Per diem will be authorized in accordance with German Mission Directive 30-5;
- c) Meals during operational meetings;
- d) Reasonable operational entertainment expenses.

4. Contingent Expenses: Although no commitment has been made to Subject regarding the items listed under a and b below, the case officer may, with the approval of the branch chief, expend funds not in excess of 2000 DM in any fiscal year for any of the following purposes:

- a) Occasional gift deemed operationally necessary and desirable;
- b) Expenditures necessary to extricate Subject from difficulties, i.e., local authorities, etc.

5. Commitments: Subject has made the following commitments to us:

- a) He has pledged secrecy regarding his activities on our behalf;
- b) He has agreed to turn over to us all documents and materials he might receive through his operational activity in our behalf;
- c) He has agreed to follow all the case officer's instructions;
- d) He has agreed to report to his American case officer all developments of his operational activities;
- e) He has agreed to serve as safehouse keeper for projects AERCARTHAGE, AERODYNAMIC and [];
- f) He has agreed to assist in all phases of agent handling for REDSOX operations involving AERODYNAMIC [];
- g) In the event of a hot war with the Soviet Union he has agreed to enter Soviet-controlled territory on any mission commensurate with the objectives of AERODYNAMIC and the Americans.

6. Commitments: The following commitments were made to Subject:

- a) We will pay for any hospitalisation or medical care required by Subject;
- b) If and when Subject decides to emigrate to America, we will assist him to emigrate and defray expenses in the amount not exceeding \$500.00
- c) A termination bonus equivalent to one month's pay shall be paid Subject.

7. Termination of the contract may be made orally at any time by the case officer or by Subject.
