Action Due to the Change in the Berlin Situation

1. A) Organization of work with the agency of the DDR.
B) Ascertain if BND office will continue to work in West Berlin and what method will be used.
C) Which specific duty has the Berlin staff, which was founded in the central office.
D) Opinions of the staff members of the central office BND about the Berlin problem.
E) Which official orders and directives were issued by the central office concerning the Berlin Question. Is plan "KUBUS" still in operation.
F) Which kind of information concerning Berlin are received in BND from the American Intelligence Service and other Western Intelligence Services.
2. Plans and actions in case of a more acute situation. (Mobilization plan, evacuation of offices, files. Possible place of evacuation.)
3. What are the intentions regarding the continuation of operation BUSCH in BND. (Where are the future meetings to take place? Would it be advisable for one of "our representatives" to make connections with "BUSCH" who would be introduced as Germans who act in the name of the Soviet Intelligence Service).
4. The present Situation.
Removal to a branch office would not be desirable from our point of view. The situation at HANNI. Official prospectives.
5. Concerning MILDNER. We have determined that MILDNER was in fact chief of police in Vienna. But it was impossible to determine where he is at this moment. In any case, there is no such person in Berlin.
6. Case "PIAZZA"
Short contents.
7. In mid-July, supposedly on order of BMI, the extension of a permit of domicile was refused for 7 Soviet engineers. Reason for the refusal. Part played by BND.

8. Warning system in the central office for the Alert. (In the filing department and in other secret offices where films and maps are kept.) Find out if actions are planned for the reinforcement of the central office.
9. In his last report KURT mentioned that he is only to concern himself with the embassy of the USSR on the FGR. But very few reports are coming in concerning actions of the BND in the embassy. Why? Why was B. not informed about preparations for the arrest of PRIPOLZEW?
10. As far as the cases TREPTE, BAAK, HORN, JACHMANN are concerned everything is clear. Repetition of these cases is not necessary.
11. Workinghours of the central office. Precise boundaries of the territory of the central office, zonal boundaries, entrance and exit routes. Control of identification papers.

The same meetingplaces for Kurt and Hanni in place of 107km Salzburg/Seemann (SEAMAN)

If there are no concrete proposals, definite meetingplaces to be agreed upon later.
