CLEMENS WORKS INDEX MATTERS, CLOSE FRIEND FRIESEN, ALSO SUSPECTED

2. ALIAS BERNHARDT STATES HAS GIVEN CAREFUL CONSIDERATION FLAP

BERNHARDT NOT AWARE WE MUST LAY ON COVERAGE KOELN VIA BRITISH.  
WHEN ADVISED THIS FACT HE STILL WANTED GO AHEAD. HE EXPRESSED  
NO FEAR BFV MIGHT ON OWN LEARN OF COVERAGE. NOTE IF WE AGREE  
REQUEST COVERAGE, WILL NOT BE ABLE TELL BRITISH WE HANDLING FOR  
UPHILL.

3. DOUBT THERE ANY PROBLEM WITH CLEMENS, BUT DEFER ADDRESSEES  
RE COVERAGE HOFMANN. NOTE HE ALREADY ANONYMOUSLY DENOUNCED AS  
MFS AGENT PLUS INTERESTING FACT FRIESEN FOR UNKNOWN REASONS
