2. SUGGEST THE ACTION BE DEFERRED PENDING COMPLETION WITH ALIAS BERGHARDT OF SPECIFIC PLAN IN WHICH SURVEILLANCE WOULD BE LIMITED SUPPORTING ELEMENT. FOR INSTANCE KUBARK OUTSIDE SURVEILLANCE MIGHT SECURE AND ENABLE UPHILL SURREPTITIOUS ENTRY AND SEARCH OF EACH ~~RESIDENCE~~ <sup>TARGET</sup> RESIDENCE WHILE HE ABSENT <sup>OR</sup> AT OTHER.
